- Spray Ground** *Includes 1 Lifeguard and 1 Pool Supervisor. Up to 50 participants.*
- Multi-purpose Room** *Includes 1 Facility Monitor to set up and break down the tables and chairs. They will also assist guest in locating the room and answer any questions.*
- Adventure Zone** *Includes 1 Facility Monitor. Up to 25 participants.*

Facility Rental Policies

Thank you for selecting Semones Family YMCA to host your event. To ensure your safety and enjoyment, we ask that you and your guests abide by the following rules and guidelines:

- 1) No food is permitted in the pool area.
- 2) The use of alcohol, drugs, or tobacco in any YMCA Facility is prohibited.
- 3) Guests are only permitted to use those areas of the YMCA designated by this contract for the time period reserved.
- 4) The facility rental is for the times listed on the rental agreement. Please do not arrive more than 30 minutes prior to the specified time as areas may be in the process of being cleaned and set up. The responsible party may be billed for an extra hour for any time over their allotted rental time. Any additional time needed before the rental must be arranged and paid for in advance.
- 5) Areas rented must be cleaned and all trash picked up when the rental time is over. Any damage to the premises or property will be billed to the above mentioned responsible party.
- 6) It is YMCA policy to conduct a swim evaluation for all participants under the age of 13 using the pool areas. The lifeguard will conduct the evaluation at the beginning of the pool rental to determine which participants will be permitted to swim in the deep. The lifeguard may also recommend that a participant wear a lifejacket. Each child will then receive a wrist band in 1 of the 3 following colors:
 - Green: Children that can swim 25 yards in a strong manner will be allowed to use the entire pool.
 - Yellow: Children that can swim approximately 15 feet, or are capable of standing in the shallow end of the pool with their head out of the water, will be permitted in the shallow end only.
 - Red: Children that cannot swim must be within arm's length of an adult caregiver at all times or must wear a US Coastguard Approved floatation device. The child will be required to stay in the shallow end of the pool. USCG approved life vests will be provided by the YMCA.
- 7) The YMCA reserves the right to remove any member or guest from the property for violation of any rules and/or behavior deemed inappropriate.
- 8) Use of the YMCA facility by individuals/groups advocating political position or for private gain is not authorized without prior approval.

Payment

A deposit of \$100 must be paid at the time the reservation is made. Full payment for the remainder of the balance is due no less than **7 days** prior to the rental date. The rental may be cancelled if fees are not paid in full by the due date.

Refund/Cancellation Policies

No Refund is given within 7 days of the rental. Deposit is non-refundable 7-14 days prior to the rental but a full refund will be given for the remaining balance if paid previously. **Full Refund** is given outside 14 days of rental.

Inclement weather may cause the pool to be closed. The rental will be given a refund prorated to the amount of time not used. Refunds for closures will only be issued if this should occur during your rental, and only if there is more than 15 minutes left of allotted time. No refunds will be given prior to the rental due to forecasted bad weather conditions.
